



## 2024 Golf Season Pass

It is essential for Woods Fort ownership and staff, to recognize the traditions and values throughout the years while while embracing the addition of newcomers to Lincoln County. To enhance the experience at Woods Fort, our ownership and Management Team has been making great strides in improving not only the golf course, the clubhouse, the restaurant, and the Barn facilities.

2023 has seen the completion of the renovated driving range with an expanded, laser-leveled hitting area and grass targets down range. In addition, new tees were added to hole #7 to help speed up play and to offer a new challenge to an already demanding hole. **However, we aren't finished yet. Here's what's in the development phase and long-range planning for:**

- **Stripping zoysia grass into the fairway of #14 and the end of the fairway on #15**
- **Short game practice area with putting green, sand bunkers, and chipping areas**
- **New irrigation system throughout the golf course improving the health and playability of the course working on budget for future development**
- **New pump station that allows for improved water flow to greens, green surrounds, and tees**

With the continued improvements to the golf course and Woods Fort amenities, we're seeing a high increase in demand for our club. Currently, we have a wait list from other private club members waiting for the announcement of our golf season pass. While many of the St. Charles County golf courses have discontinued yearly memberships completely, we respect and appreciate those who have supported us over the years which is why we're happy to offer both a **4 Day (Monday - Thursday) & 5 Day (Monday - Friday) Annual Membership**.

All Season Passes include unlimited greens fees, cart fees, and range balls for the calendar year 2024, and advance tee time reservation requests. **In addition, Woods Fort Pass holders will have reciprocal privileges at the following Walters Golf Management\* golf courses: Gateway National Golf Links, Normandie Golf Club, Far Oaks Golf Club, Stonewolf Golf Club, Innsbrook Golf Course, and Heritage at Hawk Ridge Golf Club,** a cart fee will apply, price varies by property. All tee times made at reciprocal courses must go through the Woods Fort golf shop within one day of the tee time (weekend play must be after 1pm). If your tee time is not booked through the Woods Fort golf shop you will be charged the regular applicable rates at each facility.

The club reserves the right to close the course at any time for outside bookings. **Season passes are not valid for booked events (corporate outings, charity outings, or Woods Fort sponsored events) as well as Good Friday, Memorial Day, Independence Day, and Labor Day.** All Passholders must abide by the rules set forth by Walters Golf Management and Ownership.
